RE: Adams, Robert CDC: AG0983

On November 30, 2007 Robert Adams went to the residence of a mentally disabled classmate and knocked on the door. After the unsuspecting victim opened the door, Inmate Adams pushed his way into the apartment and began taking items of value, knowing that his disabled peer would be unable to stop him. Having stolen a number of items and placing them in his car, Inmate Adams returned to the residence and demanded the victim to go with him to the bank so that he could withdraw funds to purchase methamphetamine. The terrified victim refused to leave his home, so Inmate Adams brutally assaulted him. In an effort to prevent the victim from notifying the authorities, Inmate Adams ripped the phone cord from the wall before he left. The brutalized victim suffered long term mental and physical damage from the incident, not to mention a significant increase in the frequency of seizures.

Robert Adams' criminal tenure includes an astounding eight arrests for vehicle theft. In most cases, the vehicles were completely destroyed by Inmate Adams in just the few hours or days that he occupied them. One such victim told police that the interior of her car was completely destroyed by narcotic usage; unsurprisingly, restitution was never paid in this case. This trend of thievery and destruction is commonplace in the narrative of Inmate Roberts criminal history; he adheres to no moral or ethical code in the commission of his crimes.

In the present case, Inmate Adams fully demonstrates his disdain for the law and complete lack of concern for the general public. When officers attempted to pull him over because he was driving a vehicle that had been reported stolen, Inmate Adams recklessly attempted to evade them. In the ensuing chase, Inmate Adams lost control of the vehicle and crashed into the side of a home. Determined not to give up the fight, Inmate Adams then exited the vehicle and took off on foot. With the help of a K9 unit, officers were eventually led to him hiding in a swimming pool. Unfortunately for the owner of the vehicle (which was totaled), insurance would not cover the damage to his car, so his \$9,000 car ended up being nothing more than a complete loss that was his alone to endure. It bears noting that officers also located over 17 grams of methamphetamine in Inmate Adams' possession, more than enough to conclude it was intended for distribution.

Inmate Adams is a serial offender who has never attempted to rehabilitate and assimilate into society as contributing citizen. The reckless and abhorrent nature of his crimes convey his

nefarious intent to prey upon the vulnerable and stop at nothing to achieve his ends. To better ensure the safety of the community at large, the District Attorney's Office is strongly opposed to any early release opportunity for Robert Adams.
