**Re: Eggman, Richard Lee CDC # E83296 Court Docket: 13F08281 SSD-13-283168**

Inmate Eggman is a well-established violent felon, and should not be paroled. The circumstances surrounding his current conviction and his prior criminal record show that he poses an unreasonable risk of violence to the community.

Inmate Eggman is currently in prison on a violation of Penal Code Section 459, Residential Burglary. The facts of the residential burglary involve a 70 year old Victim. While the Victim's grandson was helping his father move from the Victim's residence to a neighboring residence, the Defendant entered the Victim's residence and took clothing, food, the Victim's driver's license, Bank of America Card, prescription pills and jewelry.

When inmate Eggman committed the 2013 Residential Burglary, he already had two prior strike offenses on his record. One of those strikes was another Residential Burglary from 1991 and the other was a violation of Penal Code Section 422 from 2007. The prior 422 conviction has a disturbing and violent set of facts. In that case, the Defendant abducted his ex-girlfriend pulling her into a stolen truck against her will and driving away with her. The inmate accused the victim of infidelity stating "I'm going to kill you, f[redacted]ing b[redacted]." The inmate was convicted and sentenced to 8 years and 4 months in State Prison.

The inmate paroled from his 8 year 4 month sentence on May 13, 2013. His Parole Agent indicated that inmate Eggman violated his parole conditions in several ways. He absconded, used methamphetamine, did not attend ordered narcotic anonymous meetings and did not attend batterer's treatment sessions. Seven short months later he picked up his current commitment case.

Inmate Eggman's criminal convictions [redacted] has not let up throughout his lifetime. He is currently serving his eighth prison sentence. It should be noted that each time he is out of custody he returns for new violations or new offenses including a Prison Escape that occurred in 1996.

As we are given 30 days to respond, and we are not provided with any disciplinary history or any other information aside from the one page notice of parole review, I cannot comment on inmate Eggman's prison conduct. However, from the record that is available it is clear that inmate Eggman should not be released as he poses a significant, unreasonable risk of violence to the community. Parole should be denied.
