RE: Powers-Garibay, Jenny CDCR #WA6012

Inmate Jenny Powers-Garibay is not an appropriate early release candidate. Her underlying commitment offense and criminal history reveal a pattern of reckless dangerousness and violence. In Inmate Powers-Garibay's strike prior offense, she beat a minor female victim over the head with a large flashlight until the victim was unconscious. The attack was retribution for the victim reporting that the victim and second minor female were sexually assaulted by Inmate Powers-Garibay's male co-defendant.

In the current commitment offense, Inmate Powers-Garibay engaged in an extremely dangerous high speed pursuit through city streets while fleeing in a stolen car. She drove erratically through numerous red lights and stop signs at speeds up to 70 mph. During the pursuit, Inmate Powers-Garibay sped through a stop sign directly in front of an elementary school at approximately 9:05 a.m. on a school day. She also nearly collided with an unsuspecting driver.

Between 2002 and the commitment offense, Inmate Powers-Garibay accumulated 8 felony convictions, 2 separate prison commitments, a strike conviction, several misdemeanor convictions, and numerous parole violations/revocations.

Inmate Powers-Garibay's performs poorly under parole supervision. In May 2011, Inmate Powers-Garibay violated her parole conditions in less than 24 hours of being released from custody. She violated parole a second time within that first week when she absconded. Eventually she was arrested and incarcerated. Once released, she absconded. Again, she was arrested and incarcerated. This pattern continued when she was released in September 2011 returned to custody by November 2011.

On January 17, 2012, Inmate Powers-Garibay absconded again from the Auburn Parole. Her whereabouts remained unknown until she was arrested on February 6, 2012 for the conduct underlying her current prison commitment. Inmate Powers-Garibay's response to this latest arrest reaffirms her unsuitability to parole, "I took off high speed because I'm on parole and thought I would at least try to get away."

Parole Agent Kurtis Aronsen summarized Inmate Powers-Garibay's performance on parole: "Powers-Garibay is a dangerous individual and will likely abscond from parole supervision... Powers-Garibay is not a good candidate for parole supervision and the community would be safer the longer she is in custody." Agent Aronsen characterized Inmate Powers-Garibay's behavior on parole as manipulative, uncooperative, poor attitude, refusal to utilize resources provide to her, and "locating her has been extremely difficult."

Supervising Parole Agent Christopher Haws made the following comment/recommendation of Inmate Powers-Garibay just prior to Inmate Powers-Garibay's current prison commitment, "Powers-Garibay has not intentions of adhering to the conditions of her parole. Instead she immediately re-immerses herself in criminal activity upon being released from custody."

Inmate Powers-Garibay is a career criminal. She is violent and relentless. Granting Inmate Powers-Garibay early release would be a mistake that would significantly expose the community to unwarranted danger.
