RE: **Wilcox, Jason DeWayne** CDCR#: **AW9954** Sacramento Superior Court **14F07764**

On December 9, 2004 victim A [REDACTED] L. was walking to her car in a shopping center parking lot when she noticed Inmate Wilcox approaching her in a menacing fashion. She tried to get into her car before he could reach her but he grabbed her from behind as she unlocked her driver's door. He had her in a choke hold, and as he applied pressure to her neck, he said, "You f [REDACTED] b [REDACTED]. Get in the car you f [REDACTED] b [REDACTED]." He then pushed her into the car. Terrified that he was going to kidnap and kill her, she screamed "No! No!" at the top of her lungs and was able to activate her car alarm from the panic button on her key chain. She screamed until he released his hold and fled. She fell to the pavement but was able to alert a witness to the attempted kidnapping and the witness began to chase Inmate Wilcox. Five days later when victim A [REDACTED] L. was contacted for pictures of her injuries, the officer observed bruising to her collarbone, on her throat's 'Adam's apple', on her right hip and a bruise on her right knee. The officer noted in his report, "It was very apparent that [A [REDACTED] L.] was emotionally traumatized by this event with her tearing and sharing how frequently she thinks about the event and worries frequently about the safety of herself and her family members wherever they are."

Inmate Wilcox was with two other individuals who aided him in his escape. One of the other individuals also tried to carjack another female in the same parking lot. The three were clearly acting in concert. Inmate Wilcox was convicted of two counts of attempted carjacking, both violent felonies, in 2005 and sentenced to 3 years in State Prison.

While on parole in 2007 he was arrested in Calaveras count for robbery and allowed to plead to grand theft from the person as a misdemeanor. He also sustained a parole violation.

In 2008 he suffered another parole violation and in 2009 he was arrested for and convicted of drunk driving. In 2010 he was also arrested for and convicted of drunk driving. In 2012 he was arrested for and convicted, yet again of drunk driving.

On June 14, 2013 he was stopped by CHP in Santa Cruz when he was observed driving erratically on the freeway at 87 mph. After speaking with and observing Inmate Wilcox, the officer formed the opinion that he was under the influence and placed him under arrest. His preliminary alcohol screening tests gave readings of .20 and .21 blood alcohol level. Once he was arrested, the officer noted that his demeanor became extremely agitated. He was transported to a hospital to obtain a chemical test and was advised of the implied consent law. Inmate Wilcox stated, "F [REDACTED] that, I'm not doing anything. If you want to stick a needle in my arm you better call your homies to come hold me down." He was convicted of drunk driving with an excessive blood alcohol level and given a year in county jail.

On November 14, 2014, Sacramento Sheriff's deputies observed Inmate Wilcox doing 'donuts' in a parking lot. He was observed to have signs of alcohol impairment and was arrested for DUI. His preliminary alcohol screening tests again registered at .20 and .21 blood alcohol levels.

In the 10 years between his violent strike and his current second strike commitment, Inmate Wilcox has repeatedly placed the citizens of California at risk. Whether it's trying to carjack innocent women or driving cars which become deadly weapons when operated by individuals like Inmate Wilcox who drive with a blood alcohol limit more than 2 ½ times the legal limit, he has proven that he presents a current danger to public safety. The District Attorney of Sacramento is opposed to his early release as a 'non-violent second striker.'
