

The inmate was convicted of a Penal Code § 459 first degree burglary after he entered the garage of his mother and her boyfriend on two occasions and first took a bike, and then a tent and sleeping bag. The garage was attached to the apartment residence, although there was not a door to enter the living quarters from the garage. The inmate was given a low term sentence, even though he burglarized the property on two separate occasions and he was still on probation for his conviction for Penal Code § 245 (a)(1). The inmate had a strike from a prior Penal Code § 422, so his sentenced was doubled to four years.

The Penal Code § 422 conviction came after the inmate was observed going through the victim's garbage collecting cans. When the female victim asked him what he was doing he at first ignored her. That caused her to again say 'Hey, I'm talking to you'; at which point he yelled "F███ you bitch, I will slap your f███ing face off, I know where you live." The victim ran into the house, and her husband came out. The inmate yelled "I know where you all live, I will come back and kill all of you". In addition the inmate yelled several times at the husband that he was going to come back and kill them and rape his wife. The inmate picked up his cans and left, but the husband followed him to assure his apprehension. Upon arrest the inmate told officers he was collecting cans for recycling and just wanted to be left alone, but the male victim kept following him so the inmate felt threatened. On 07/09/ 09 the inmate was convicted of his first felony conviction Penal Code §422 and given 16 months state prison.

While on parole for the strike offense, the inmate on 8/13/2012 was observed on the close circuit camera scratching the TVs in apartment complex gym. The inmate lived with his mother in the complex. The apartment manager sent the mother and inmate an eviction notice. The inmate entered the office of the complex screaming that they are not to send his mother any more letters. He dropped a glass candy dish on the ground breaking it. The inmate came toward the manager a few times saying he was going blast him. The inmate then left and tried to turn over a golf cart outside, but failed. No one was injured. The inmate was charged with Penal Code §422, but was allowed to plead to a reasonably related Penal Code § 245(a) (4) to avoid a strike conviction. He was given probation, which he violated when he committed the burglary of his mother's garage.

The District Attorney respectfully requests that the Board find this inmate unfit for early parole.
