A review of inmate Rodriguez's CII criminal history reveals a predatory and abusive criminal pattern escalating in severity and frequency. Between the years of 2001 and 2013, law enforcement had to make contact with inmate Rodriguez no less than thirteen (13) times for kidnapping, false imprisonment, inflicting corporal injury on a spouse/cohabitant, willful cruelty to a child, force with a deadly weapon-not firearm, but with great bodily injury likely and threatening crime with intent to terrorize with many of those contacts resulting in criminal cases.

Although a Pre-sentence Investigative Report was not filed by our Probation Department on the case for which he is currently in prison, I am attaching a prior report on his prior felony case which resulted in a prison commitment for the details which it provides about his extensive criminal background.


In 2003, inmate Rodriguez held his girlfriend and his girlfriend's then 8 year old daughter hostage in their own home—the one place, especially for a child, you should be allowed to feel the most secure. After suffering hours of abuse at the hands of inmate Rodriguez, it was the 8 year old child, who, from behind the locked bathroom door, was able to dial 9-1-1 for help. On April 19, 2005, inmate Rodriguez spotted the mother of his child driving her car en route to pick up her 10 year old daughter from school and he gave chase. After speeding past her, he swerved his truck in front of her forcing her to slam on her brakes to avoid a collision and causing her to nearly lose control of her vehicle. The victim was only able to get away from inmate Rodriguez after she made an illegal U-turn in on-coming traffic. Rodriguez's recklessness in an attempt to corner his victim and her illegal defensive maneuver put multiple people at risk and made all those in the vicinity at that time, his victim. Sadly, it took four more law enforcement visits within as many months for inmate Rodriguez to be arrested for his continued harassment of this victim. Clearly, inmate Rodriguez has no problem terrorizing women and children as evidenced by his multiple law enforcement contacts and subsequent court charges for those very things. But when it comes to accepting responsibility for those actions, inmate Rodriguez scatters like a cockroach running from the light.

In 2013, inmate Rodriguez was a parolee at large and known to carry firearms. Galt police officers attempted to make contact with inmate Rodriguez but he took off in his full-sized truck. What resulted from that attempted contact was a high speed chase with speeds reaching up to 100mph, lasting approximately 30 minutes and covering about 19 miles of roadway through Galt and Sacramento County. Not only did inmate Rodriguez fail to yield to emergency lights, he straddled the double yellow lines in traffic and forced non-involved motorists and on-coming traffic to swerve to get out of his way. In his flagrantly willful and wanton disregard for the safety of officers and the public, inmate Rodriguez also failed to stop at the, at least, three stops signs he blew through before finally abandoning his car off an

embankment and taking off on foot. It was in deep brush where a police canine finally located him hiding and ultimately apprehended him.

Inmate Rodriguez has demonstrated time and time again that he poses a consistent and continuously viable and unreasonable risk to *all* private citizens, young and old alike as well as to our public safety officers. One would be hard pressed to find an individual less deserving of a shortened sentence. The Sacramento County District Attorney's Office vehemently opposes inmate Rodriguez's early parole.
