Re: Justin Michael Doerner, #BE3023, 17FE014720

Inmate Doerner is a well-established violent felon, and should not be paroled. The circumstances surrounding his current conviction and his prior criminal record show that he poses an unreasonable risk of violence to the community.

In the early morning of August 17th, 2011, Victim D [REDACTED] woke up just like any other day. He opened his door to the garage to find that the garage door was open which seemed strange to him. He then walked to his vehicle that was parked in the driveway. The Victim found that his vehicle had been ransacked. He then went to check the inside of his house. He discovered that the shorts he left at the foot of his bed were missing. He had left his wallet in the shorts the night before. He also discovered that numerous items were missing, including: cameras, laptops, DVDs, and keys to their house and car. Victim D [REDACTED] was shocked and scared. His house had been broken into, ransacked, and all while he, his wife, and their three young children were sleeping.


However, the violation of the Victim's family home did not stop there. Officers discovered that Inmate Doerner and a co-defendant were using the family's credit cards to make numerous purchases the same morning of the burglary. Ultimately, Inmate Doerner was convicted of the strike offense of first degree residential burglary and sentenced to 2 years in state prison.

Unfortunately, Inmate Doerner's criminal history does not stop there. In a very similar set of circumstances, Inmate Doerner in 2017 approached a residence in the middle of the night with the intent to steal. The homeowner woke up and saw Inmate Doerner and a co-defendant attempting to hook up a cargo trailer to a vehicle. The homeowner made a noise and Inmate Doerner fled. Officers tracked Inmate Doerner back to his residence. When they searched it, they found property from multiple other burglaries, including passports, checkbooks, credit cards, and a card skimmer. Inmate Doerner ultimately pled to a violation of Penal Code section 530.5 and sentenced to 32 months state prison.

Inmate Doerner's criminal history also includes a theft conviction in 2009, a felony conviction for possession of a dangerous weapon in 2010, another violation of identity theft in 2016, and multiple probation and parole violations.

As we are given 30 days to respond, and we are not provided with any disciplinary history or any other information aside from the one page notice of parole review, I cannot comment on Inmate Doerner's prison conduct. However, from the record that is available it is clear that Inmate Doerner should not be released as he poses a significant, unreasonable risk of violence to the community. Therefore, the People request Inmate Doerner's parole be denied.
