**RE: Ramborger, Michael Ray**

**CDC# AR-5050**

Inmate Ramborger is a violent, anti-social offender. The circumstances surrounding his current conviction and his prior criminal record show that he poses an unreasonable risk of violence to the community.

In the instant case, Roseville Police Department officers began conducting surveillance of Inmate Ramborger knowing that he had a long history of drug sales convictions, that he was out on bail from Placer County on a drug transportation case, and that he was on searchable PRCS for drug transportation (HS 11379). On September 5, 2012, Officer's followed Inmate Ramborger in undercover vehicles to a parking lot in Sacramento County and observed him conduct a hand-to-hand drug transaction. Shortly thereafter, Ramborger was detained pursuant to his searchable PRCS status. His person and vehicle were searched for contraband. The search revealed 43 grams of methamphetamine in the pocket of his shorts and \$550.00 in U.S. currency. Upon searching the vehicle, Officers found a shopping bag on the front passenger floorboard. Inside the bag, officers found three baggies containing approximately 7 grams of Heroin, two baggies containing approximately 135 grams of methamphetamine, numerous plastic baggies commonly used for drug sales, a digital scale, and a black fanny pack. A search of the black fanny pack revealed a loaded .22 caliber pistol and several rounds of .22 caliber ammunition.

This conduct is particularly disturbing given Ramborger's horrendous criminal record and his life-long commitment to selling drugs. On August 25, 2010, Officers attempted to make a vehicle stop on a truck containing a driver and a passenger (Inmate Ramborger). Suddenly the driver stopped the truck in the middle of the street and fled on foot. Ramborger remained. A search of the vehicle revealed a fanny pack which contained 21 grams of methamphetamine, a pay-owe sheet, and numerous baggies commonly used in drug sales. Ramborger subsequently was arrested, plead to HS 11379(a), and was sentenced to state prison.

On August 5, 2003, officers made a vehicle stop on a car which Ramborger was driving. 4 grams of methamphetamine were found on his person and 7 grams of methamphetamine were found in the vehicle, along with numerous baggies typically used in drug sales. Ramborger was subsequently arrested, plead to HS 11378, and was sentenced to state prison for 9 years.

On October 10, 2001, Ramborger was on parole and recently released from prison. A search was conducted of his parole address and under the Defendant's bed officers found approximately 3 grams of methamphetamine, a digital scale, baggies and a pay owe sheet. In an interview, Ramborger admitted to selling methamphetamine in order to make some money. He was arrested, plead to HS 11378, and was sentenced to state prison.

On February 2, 1999, Ramborger was on parole and present in the garage of his parole address when it was searched. The search revealed approximately 1 ounce of methamphetamine, a scale, baggies, and a pay-owe sheet. The Defendant also had over \$900.00 on his person. He was arrested, plead to HS 11378, and was sentenced to state prison.

On July 26, 1991, Ramborger was contacted in a residence and a consent search was conducted. That search revealed approximately 11 grams of methamphetamine, a scale, baggies, a pay-owe sheet, and a loaded sawed off shotgun. Ramborger was interviewed and admitted to selling methamphetamine and to possessing the shotgun. He was arrested, plead to HS 11378, and was sentenced to state prison. Inmate Ramborger has been a criminal his entire life and a complete menace to society. Lengthy and repeated prison sentences have not rehabilitated him or motivated him to live a productive, law abiding life. He has made no effort to be a contributing member of society... EVER! In fact, almost all of Ramborger's convictions occurred while on some sort of formal law enforcement monitoring (i.e. - Parole or PCRS), which shows his total lack of regard for the system or regard for how his continued drug dealing effects his community.

From age 25 to age 45, Ramborger has completely refused to change his behavior. People like Ramborger deserve an extended sentence, until their rehabilitation is clearly established. After consistently selling drugs for the past 20 years, the Board cannot possibly say this Inmate has been rehabilitated in less than six years and that his armed drug trafficking does not pose a significant risk of violence to our community.

As we are given 30 days to respond, and we are not provided with any disciplinary history or any other information aside from the one page notice of parole review, I cannot comment on inmate Ramborger prison conduct. However, from the record that is available it is clear that inmate Ramborger should not be released as he poses a significant, unreasonable risk of violence to the community. Parole should be denied.
