Re: Kendrix, Anthen CDC # BW0926 Court Docket: 20FE012658

To say that Inmate Kendrix is a well-established felon would be an understatement. His continuous criminality confirms that he should not be paroled. The circumstances surrounding his current convictions and his prior criminal record show that he poses an unreasonable risk of danger to the community.

Inmate Kendrix is currently serving a 7 year and 4 month prison commitment for violations of Penal Code section 4573 and Health and Safety Code sections 11351.5 and 11378 that occurred in 2020 and 2021. In Docket 20FE012658, Inmate Kendrix was on probation when his vehicle was stopped by law enforcement on August 11, 2020. He was the only occupant of the vehicle. A probation search was conducted and officers located 14 grams of methamphetamine, 29 grams of cocaine, cash in small bills, small individual plastic bags, and a cell phone which contained many text messages about narcotics sales. Inmate Kendrix was arrested.

Inmate Kendrix was released on bail and approximately seven months later, he was arrested again for violations of Health and Safety Code section 11378 and Penal Code section 4573 on March 9, 2021 and charged in Docket 21FE004384. Inmate Kendrix was still on probation at this time. In that case, an anonymous tip came into law enforcement that Inmate Kendrix was selling narcotics. Officers set up surveillance on Inmate Kendrix's home and watched many hand-to-hand transactions occur. A probation search of the home was conducted and officers found approximately 28 grams of methamphetamine, two cell phones, and cash. Inmate Kendrix was arrested and when searched at the jail for booking, it was discovered that he had brought approximately 13 grams of rock cocaine into the jail. Docket 21FE004384 was subsequently consolidated into Docket 20FE012658 and dismissed.

Inmate Kendrix was once again released from custody and on February 10, 2023 was once again arrested for violations of Health and Safety Code sections 11351.5 and 11350(a) and charged in Docket 23FE002272. In that case, Inmate Kendrix was driving his vehicle when it was stopped by law enforcement. A search of the vehicle revealed a digital scale with cocaine residue on it, a prescription bottle for "Daniel Storino" with 10 Hydrocodone pills, cash, a liquor bottle with a store security cap still on top of it, approximately 5 grams of powdered cocaine, 25 grams of

rock cocaine, and a cell phone. Inmate Kendrix was arrested and finally kept in custody. On July 20, 2023, Inmate Kendrix accepted a plea deal sentencing him to his current prison sentence, which allowed him to get dismissals for several of the pending charges.

These are only Inmate Kendrix's most recent convictions. Since turning 18 years old, Inmate Kendrix has been convicted of 9 felony charges and 12 misdemeanor charges. Since 1991, he has never made it more than 5 years before he is convicted of another crime, time and time again. He has been to prison 6 different times and has a prior strike conviction for a violation of Penal Code section 245(a)(1), Assault with a Deadly Weapon. Inmate Kendrix has repeatedly and continuously terrorized the public by assaulting people with weapons, selling narcotics to the vulnerable in our community, and violating his parole and probation time and time again. His misdemeanor offenses have also been dangerous to society and violent, being convicted of evading the police, battering victims, resisting arrest, and domestic violence.

Not only does Inmate Kendrix's criminal history confirm that he is inherently dangerous to the public, but it also shows that he is not amenable to any forms of supervision. Given the consistent criminal activity and convictions, Inmate Kendrix has been placed on numerous forms of wardship, informal and formal probation, and parole. However, despite those grants of supervision, he has continued to repeatedly offend. He was on probation for two of the three dockets that his current sentence originates out of. He is unwilling to deviate from his criminal behavior, and certainly unwilling to listen to any lawful directives while released from custody. Should Inmate Kendrix be released, he will continue to victimize innocent people and the Sacramento County community, as he has done time and time again in the last 20 years.

As we are given 30 days to respond, and we are not provided with any disciplinary history or any other information aside from the one page notice of parole review, I cannot comment on Inmate Kendrix's prison conduct. However, from the record that is available it is clear that Inmate Kendrix should not be released as he poses a significant, unreasonable risk of violence to the community. Additionally, Inmate Kendrix has shown that he would not be amenable to the conditions of any early parole. Parole should be denied.
