Re: Marcus Dante Campbell CDC # AC2212 Court Docket: 13F02664

Inmate Campbell has led a life of committing violent crimes and he should not be paroled. The circumstances surrounding his current conviction and his prior criminal record show that he poses an unreasonable risk of violence to the community.

On September 24, 2009 in Sacramento County Marcus Campbell broke into the home of while she was away running errands. It appeared he gained entry through a small kitchen window, and once inside he stole checks, jewelry and a laptop computer. Subsequently a fingerprint latent matched the print of Campbell. On March 25, 2013 Marcus Campbell broke into the home of early in the morning while she and her niece were still sleeping in the home. Ms. woke to hear glass breaking downstairs. It was very loud and she knew someone was breaking into her home. She called 9-1-1 and then went out of her bedroom to make sure her niece was okay. She came out into the hallway from her bedroom and saw Campbell coming up the stairs. out loud, telling Campbell to get out of the house. Instead of leaving, Campbell advanced on She ran into her bedroom and locked the door. Campbell tried to get into the bedroom. but he was unsuccessful because it was locked. Campbell went back downstairs and was looking was afraid Campbell would hurt her niece who was downstairs and kept yelling at Campbell to get out and for her niece to stay in her room. Eventually, Campbell left and he was apprehended a short time later. On March 13, 2014 Campbell broke into the home of when was on vacation.

The alarm was activated and a neighbor responded. A window screen had been removed and a window broken in order to gain access. Campbell removed a jar of coins and an Oriental jewelry box. Also, the owners were unable to locate a bracelet and a ring. A fingerprint of Campbell's was located on the window screen of the residence.

In addition to the above burglaries, Campbell has been convicted of a First Degree Felony Burglary from Sutter County on 2-9-2010, a misdemeanor H&S 11377 in 2011 from Sacramento County, and a Felony PC 496 from Sutter County on 1-27-2010.

This board denied Campbell's previous petition for relief. In its ruling of March 25, 2020, this board gave "great weight" to Campbell's violent conduct in prison, noting that "the assaultive behavior that the inmate perpetrated in the RVRs for fighting demonstrates his impulsivity, his disregard for CDCRs policies and procedures, and continued criminal behavior." We believe that reasoning was sound.

Based on the above record and conduct, Inmate Campbell remains a danger to the community—whatever community he is in. Parole should be denied.
