**Re: Trudeau, Frank      CDC # BJ9611      Court Docket: 19FE000017, 19FE005369**

Inmate Trudeau is a repeat offender and should not be paroled. The circumstances surrounding his current conviction and his prior criminal record show that he poses an unreasonable risk to the community.

On December 28, 2018, law enforcement initiated a traffic stop on Inmate Trudeau when he was seen driving on a curb. Inmate Trudeau was on active probation stemming from his 2015 conviction of Vehicle Code section 2800.2 and PRCS for his conviction of Penal Code section 30305(a)(1) from 2016. Law enforcement conducted a pat search of Inmate Trudeau, which revealed two knives, a stun gun, 2.7 grams of methamphetamine and a methamphetamine pipe on Inmate Trudeau's person.

On March 25, 2019, while Inmate Trudeau was out on bail for the above offenses, park rangers contacted Inmate Trudeau in a vehicle in River Bend Part to conduct a park fee compliance. Inmate Trudeau was on PRCS, so the rangers conducted a PRCS search of the car. Rangers located a .32 caliber semi-automatic handgun, a loaded .32 caliber revolver, 26 live rounds of ammunition and a black throwing star in the vehicle.


These are not Inmate Trudeau's first criminal offenses. Inmate Trudeau has been convicted of numerous felonies stemming back to 1990. In 1990, Inmate Trudeau was convicted of four counts of First Degree Burglary, for which he was sentenced to eight years in state prison. In 1995, Inmate Trudeau failed to comply with the conditions of his parole and sustained a parole violation. Subsequently, in 1996, Inmate Trudeau was convicted of violating Health and Safety Code section 11377(a), for which he was sentenced to 26 years to life. Ultimately, when Inmate Trudeau was released from prison in 2012, his sentence was modified to seven years state prison. Thereafter, Inmate Trudeau continued his criminality by committing a felony violation of Vehicle Code section 2800.4 in 2015. While on probation for that offense, Inmate Trudeau was being investigated for a domestic violence incident when law enforcement located 4 live rounds of ammunition on Inmate Trudeau's person. This resulted in Inmate Trudeau's conviction for PC

30305(a)(1) in 2016. While still on probation for his 2016 offense, Inmate Trudeau also sustained convictions for PC 29800(a)(1) and PC 21310 in 2019.

Inmate Trudeau's numerous prison commitments have failed to stop his criminality. Inmate Trudeau's criminal record stemming back 30 years shows his total disregard for the law. An even more blatant disregard for the law is displayed by his continuous failure to comply with his probation, parole and the terms of his bail. Despite being a convicted felon, Inmate Trudeau continues to consistently possess weapons, posing a danger to the community. If Inmate Trudeau is released from parole early, it is likely he will continue to engage in dangerous behavior and fail to comply with conditions of his parole given his repeated failure to comply with the law and probation since 1990.

As we are given 30 days to respond, and we are not provided with any disciplinary history or any other information aside from the one page notice of parole review, I cannot comment on Inmate Trudeau's prison conduct. However, from the record that is available it is clear that Inmate Trudeau should not be released as he continues to have a complete disregard of the law and present an unreasonable risk of violence to the community. Parole should be denied.
